Functions and performance levels:

**basic requirements for safety footwear** (see Table 2 and 3 of EN ISO 20345:2011): all mandatory ones, among which:

**SRC = Slip resistance** – meets the following requirement:

- surface: ceramic / lubricant: detergent solution;
- surface: steel / lubricant: glycerol.

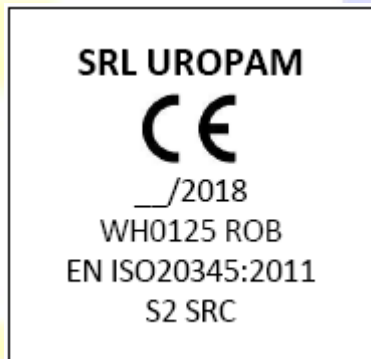
**Additional requirements** (Tab. 18 and 20 of EN ISO 20345:2011):

**S2** = closed seat region, antistatic properties, energy absorption of seat region, resistance to fuel oil, water penetration and absorption.

Marking:

on a stitched label and displaying the following information:

- **CE Marking**;
- Name of the Manufacturer;
- designation of the footwear (alphanumeric code + commercial name);
- number and year of the Standard of reference + safety symbols;
- size of the footwear (printed on the outsole);
- month and year of production.



NOTE: the Technical File contains a more detailed description of the PPE (material, method of assembly, photographs or drawings), performance data, safety functions and level of protection, elements of conformity to the basic and supplementary requirements. The Technical File is integral part of the present Certification, which has to be kept available by the applicant to be forwarded - upon request - to the entitled person (supervising body, Controlling Officer).
